# **6.2** Management of the Translation Center

The CIML, in Resolution no. 7 of the 46th CIML Meeting, resolved that the funds in the special account of the BIML Translation Center may be used, as necessary, for translation and interpretation activities that are not currently part of the normal operation of the BIML. The CIML also instructed the BIML to report annually on the functioning of the BIML Translation Center.

At the end of 2011 the balance of the BIML Translation Center special fund was reduced by €1000 compared to end of 2010, as shown in the following graph:



Following the CIML Resolution mentioned above, the BIML started to actively search for skilled technical translators. Such persons are hard to find. Fortunately, with the assistance of Corinne Lagauterie (CIML Member for France), some native French speaking experts from the LNE were contracted to translate some publications within their respective fields of expertise.

Based on Resolution no. 7 from the 46th CIML Meeting, English to Spanish interpretation will be provided on an experimental basis at the 47th CIML Meeting and 14th Conference.

Combined with the reduction in the voluntary contribution, these activities will continue to reduce the balance in this special account.

# **6.3 OIML Pension system**

Six retired BIML staff members currently benefit from the OIML Pension system and one active staff member is contributing to the system and will benefit from it upon his retirement.

The option to join the OIML Pension System is no longer given to newly recruited staff members and references to the system have been removed from the draft for the revision of the BIML Staff Regulations (OIML B 7).

With a projected pension inflation rate of 2.5 % in the 2013-2016 financial period, the value of those benefits for 2011-2016 are as follows (2012-2016 projected):

# **6.4** Revision of the Financial Regulations

A draft for the revision of OIML B 8 *OIML Financial regulations* is proposed by the BIML Director following the changes in the accounting system as a result of the implementation of relevant IPSAS standards. The draft also includes amendments bringing the provisions of OIML B 8 more in line with the provisions of the Convention (OIML B 1).

The draft revision of OIML B 8 is available on the CIML Meeting web site at: http://bucharest.oiml.org/ciml.html.

According to Article XXVII of the Convention, the Committee shall prepare a financial code based on the provisions of Articles XXIV to XXVI. From the wording of Article XXVII ("shall prepare") it follows that the "financial code" has to be submitted to the Conference for adoption.

# 6.5 Contributory classification of Member States

According to Article XXVI (1) of the Convention, Member States are classified according to the size of their population and may be put in a lower class when the use of measuring instruments is clearly below the average. In 2005, the CIML decided on a procedure to implement this provision of the Convention. This allowed World Bank data on GNI per capita to be used as an indicator of the use of measuring instruments and as the basis for annual classification reviews.

It should be noted that an annual review with the objective to reclassify Member States is not in line with Article XXVI (1) of the Convention which implies that the contributory share of a Member State is fixed for the financial period and that the annual contribution is determined by equally distributing the share of a Member State over all the years of a financial period. In practice annual reviews have not taken place and it is therefore now recommended that reclassifications should be initiated for the whole financial period, based on a review in the year immediately prior to that period. However, because the Conference decides on the contributory shares at a time when the Member States would already have prepared their budgets for the first year of the next financial period, the change in contribution should be made effective only from the second year of the financial period.

On the agenda for the 14th Conference (agenda item 8) is a draft resolution confirming the procedure for the Member States' classification review as approved by the CIML at its 40th Meeting in 2005 and stipulating that such review takes place in the year before a new financial period only.

For the 2013-2016 financial period, the classification review in 2012 results in the following reclassifications:

Algeria: from Class 1 to Class 2;
P.R. China: from Class 3 to Class 4;
Cuba: from Class 1 to Class 2;
Egypt: from Class 1 to Class 2;
India: from Class 1 to Class 2;
Indonesia: from Class 2 to Class 3;
Iran: from Class 2 to Class 3.

These reclassifications have been included in the proposed annual budgets for the 2013-2016 financial period, effective from 2014.

- (d) the OIML does not provide direct aid to Developing Countries, nor does it finance technical assistance projects in a particular country;

<u>Approves</u> the BIML Director's proposal to create a special fund to support the OIML activities aimed specifically at Developing Countries,

<u>Requests</u> the 14th Conference to take this Resolution into account when deciding the overall amount of credits necessary to cover the OIML's operating expenses in the 2013-2016 financial period.

### 9 Technical activities

# 9.1 Proposals for amending the Directives for OIML technical work

The ad hoc working group, established by the CIML at its 46th Meeting, and chaired by the second Vice-President, Roman Schwartz, has considered comments from CIML Members on the *Directives for OIML technical work* (OIML B 6) and has made proposals in the form of draft revisions of OIML B 6-1:2011 and B 6-2:2011.

During the consultation process two specific issues were raised which the ad hoc working group would like the CIML to discuss and decide on:

# a) Applicability of the Directives to OIML Basic publications

The second paragraph of clause 1 (Scope) of B 6-1 states:

"The category of OIML publications known as "Basic Publications" (B), which set out the general operating rules of the Organization, are not regarded as representing technical work and are outside the scope of these Directives. These publications include the OIML Convention (ratified by each OIML Member State), general publications approved by the Conference (such as the Financial Regulations) and general publications approved by the CIML (such as the Guide for CIML Members, Staff Regulations, Directives for technical work, etc.)."

The ad hoc working group proposes that this is changed to the following:

"The category of OIML publications known as "Basic Publications" (B), which set out the general operating rules of the Organization, are not regarded as representing technical work, however, the rules set out in this document should also be followed in the production of any Basic publication if the CIML so decides."

<u>Noting</u> the proposal from the ad hoc working group on the revision of OIML B 6:2011 Directives for OIML technical work,

<u>Confirms</u> that the rules set out in OIML B 6 shall only apply to the development, revision or amendment of OIML Basic Publications if the CIML so decides for a particular Basic Publication.

#### b) Corresponding Members' participation in OIML technical work

At its 33rd Meeting (1998, Seoul), the CIML agreed that Corresponding Members could register as O-members of TCs and SCs. There were also discussions under item 2.3 at the 34th CIML Meeting (1999, Tunis), where it was reported that some Corresponding Members were participating in certain TCs/SCs.

The ad hoc working group proposes that the CIML confirms that Corresponding Members may participate in the work of TCs/SCs/PGs as O-members.

#### 9.2 Items for information

# 9.2.1 Revision of OIML V 1 "International Vocabulary of Legal metrology"

The draft revision of OIML V 1 did not receive sufficient support in the CIML preliminary ballot. Two CIML Members voted "no" with comments requiring substantial changes to the draft. The convener of TC 1/p 2 will consider the comments and develop a further CD. A meeting of TC 1/p 2, early in 2013, is being considered.

### 9.2.2 Status of TC 6 work project p1 "OIML Certificate system for prepackages"

TC 6 rejected the 3CD for an OIML Basic Publication "International system for the certification of prepackages as complying with requirements for the quantity of product and associated labeling" (OIML Certificate system for prepackages) for almost exclusively "non-technical" reasons.

TC 6 will meet on 22-26 October 2012 in Tokyo and discuss the way forward with this project.

### 9.3 Items for approval

### 9.3.1 Approval of the draft revision of OIML R 126 Evidential breath analyzers

The draft revision of OIML R 126 had been submitted to the preliminary online ballot with a deadline of 8 August 2011. The draft received a sufficient number of "yes" votes (29) but also 5 "no" votes with objections that would require substantial changes to the draft. The draft was returned to the TC 17/SC 7 secretariat for reconsideration and to prepare a further draft, taking the comments into account.

The 46th CIML Meeting decided that the draft could be submitted to direct CIML online approval once it received sufficient support at the preliminary ballot stage.

In February 2012, TC 17/SC 7 met to discuss the comments, but no consensus could be reached. The secretariat reported to the BIML that the objections expressed in the ballot had been discussed many times since 2003 and that it did not see any possibility to reconcile the opposing views and prepare a draft that would remove the objections.

The current Directives for OIML technical work (OIML B 6-1:2011) do not have provisions for this situation. A proposed amendment to B 6-1:2011 (agenda item 9.1) calls for the BIML to consult with the CIML President who will try to resolve the situation, and if necessary, make a proposal to the CIML.

The CIML President regrets that it was not possible to reach full consensus on the technical content of the draft. However, it appears that all parties agree that the text of the present draft is a substantial improvement compared to the version of R 126 currently in force. Those countries that voted "no" in the preliminary ballot would like to see further requirements introduced before they are able to use any version of R 126.

- (b) After consultation with its members, the secretariat of TC 17/SC 7 did not see any possibility to prepare a further draft that would remove the objections expressed in the preliminary ballot,
- (c) The revised text is a substantial improvement on the current version of OIML R 126, even though it did not receive full consensus,

The draft revision of OIML R 126 "Evidential breath analyzers" is approved.

## 9.4.2 Amendment to OIML B 10 – Procedure for approval by the CIML

In Resolution no. 21 of its 46th Meeting, the CIML approved the amendment to, or revision of OIML B 10 Framework for a Mutual Acceptance Arrangement on OIML Type Evaluations (MAA) to include appropriate conditions for the registration of Manufacturers' Testing Laboratories (MTLs) under a DoMC, as a new work project for TC 3/SC 5.

The Final Draft Amendment to OIML B 10, as approved by TC 3/SC 5, is currently out for CIML comments. This text, as well as the comments received, will be available on the CIML Meeting web site at: http://bucharest.oiml.org/ciml.html approximately one month before the CIML Meeting.

OIML Basic Publications are not covered by the *OIML Directives for technical work* (OIML B 6:2011). Since previous revisions of B 10 have followed the approval process of OIML Recommendations, the CIML will need to discuss and decide on the approval procedure for the Amendment to OIML B 10. In this case it is considered that the current proposal to amend OIML B 10 has been discussed at length and that applying the rules of OIML B 6 would merely cause further delays.

# 9.5 The new SI and the impact on legal metrology

The 46th CIML Meeting encouraged CIML Members and relevant OIML Technical Committees to actively participate in the discussion on "the new SI" and provide comments to the ad hoc OIML working group "New SI". On the basis of the comments received the chair of the ad hoc working group and CIML second Vice President, Roman Schwartz, proposes the following statement for adoption by the CIML in response to Resolution 1 (2011) of the CGPM:

"The OIML supports the CGPM's intention to revise the SI in order that it will continue to meet the needs of science, technology, and commerce in the 21st century.

From the inquiry amongst the OIML Technical Committees TC 2, TC 9, TC 9/SC 3 and TC 11, and the CIML Members, it is concluded that the new SI definitions are considered to have little to no impact on routine measurements of time, length, luminous intensity, electric current, temperature, amount of substance, and related derived SI quantities. A potential impact may be on accurate mass measurements using weights of classes  $E_1$  and  $E_2$  according to OIML R 111. Only careful adherence to the 2010 recommendations of the CCM will preserve the continuity, accuracy and traceability of future mass measurements.

The OIML supports the intention of the CGPM to further improve formulations for the definitions of the SI base units so that the new SI remains understandable to all those who need it."
